National Trail Parking Lot Rules & Regulations

The following regulations will be enforced pursuant to the provisions of Vehicle Code Section 4511.68 of the State of Ohio.

1. A student driver must obtain a parking contract form from the NTHS Office. This contract must be taken home, read and signed by the student and the parent/guardian, and returned to the NTHS office.
2. Student driver will be issued a parking pass upon meeting the following:
 - Proof of insurance is shown.
 - After they have signed an agreement to follow the rules and regulations for driving.
 - \$20.00 parking permit fee is paid.
3. Upon receipt of the signed contract, the student's car will be registered and he/she will be issued a numbered hanger permit to be placed on the rear view mirror facing out. This hanger must be displayed while parked on campus.
4. There is a fee of \$20 for regular parking (Passes purchased after 3rd quarter will be reduced to \$10.00)
5. All student drivers will arrive at school on time. When a student driver is tardy the third time, his/her driving privileges will be suspended for the remainder of the grading period.
6. Students who miss more than 10 days per year or receive five tardies per semester to school may lose their driving privileges.
7. Student drivers who leave school grounds without permission during the day will have their driving privileges suspended. Driving a vehicle to school is a privilege that may be revoked.
8. Reckless driving and excessive speed in the parking lot or in the vicinity of the school will not be tolerated and will draw immediate loss of parking privileges. The speed limit in the parking lot is 5 MPH.
9. Once a car is driven onto the lot it must be parked. Cruising in and out of the lot or in front or back of the school is not permitted.
10. Students are to leave the parking lot area as soon as their cars have been parked. The lot is off limits during the school day. Students are not allowed to eat lunch in their cars or work on them during this time.
11. Student drivers who must leave during the school day for medical or family business must bring a note from their parents and follow regular attendance procedures.
12. Students are not permitted to park in Faculty, Staff, Visitor, Reserved, or Handicapped areas.
13. Cars should be locked at all times while parked at school.
14. Any violation of the Vehicle Code or other laws governing parking will be cited. All vehicles must head into parking spots, take only one parking spot, not park in restricted parking zones, not block other vehicles, and have the hanging parking permit displayed.
